

#### Treatment:

Exercise therapy Massage Leg elevation Weight loss Compression stockings Sequential compression devices Injections (sclerotherapy) Endovenous ablation (Closurefast™ and VenaSeal™ Closure) Surgical phlebectomy

### Parkview Health at Home (PHAH)

- Parkview Home Health entered a 50/50 joint venture with CommonSpirit. The new home health entity is called Parkview Health at Home. With this transition, Cardinal Family Care will begin providing orders and patient oversight similar to what Suresh Jaiswal, MD and team has been doing. Current home health patients will continue with Dr. Jaiswal until they are discharged from home health. Patients admitted to home health after May 19<sup>th</sup> will be managed by Cardinal Family Care providers. They will function as the home health hospitalists. Once the home health episode of care is finished the patient will be transitioned back to our primary care providers.
- PHAH is partnering with Cardinal Family Care for the care of our patients while they are on home health.
